This will be a merger of equals in which all assets will be pooled and shareholders from both practices will surrender their shares for new ones issued by the newly configured company. All physician shareholders will be equal partners in the new Consulting Cardiologists, PC. The license name will remain Consulting Cardiologists, P.C., with business address of 85 Seymour Street, #719, Hartford, CT 06106 and contact Sandra Llegi, Practice Manager, phone number of (860) 522-0604 and fax of (860) 522-1761.

The quarterly dose calibrator linearity test at CACC presently utilizes attenuating sleeves, but a change to the source decay method will be effected. The status of QC, calibrations, leak tests, area surveys, wipe tests, training, and related record keeping is up to date. The removal for disposal of old sealed sources, which are no longer suited for QC testing, will be undertaken.


