As directed by Order EA-14-190, Reference 1, STP Nuclear Operating Company (STPNOC) submitted a twenty-day response consenting to the Order, and described the methods of compliance in Reference 2. By References 3 and 5, STPNOC submitted to the NRC requests for date extensions to be in compliance with the Order. In References 4 and 6, the NRC granted the requested extensions.
