Dear Stephen and Jane,

Thank you for notifying me of the discrepancy you found on QSA Global Inc.'s Category 1 Radioactive Shipment Notification# 2018-022. The discrepancy was an oversight on my part and I should have included Se-75 and the activity on the notification.

My process for making our Category 1 notifications involves reviewing our manufacturing schedule for Ir-192 and then making the notifications in accordance with that schedule. The Se-75 is scheduled separately and I was not aware that this shipment would contain Se-75 at the time of notification.

As a result, going forward, for any suppliers that may also provide Se-75, I will also consult the Se-75 manufacturing schedule prior to submitting the Category 1 notification. I have also updated the Notification form to ensure it will have space available to include the additional isotope and activity.

I hope this helps to explain the reasoning for my oversight and I am confident the resulting corrective actions will prevent me from making this mistake in the future.
