ORDER

On September 6, 2018, the NRC provided notice in the *Federal Register* of the opportunity for members of the public to file a request for a hearing and petition for leave to intervene in a proceeding involving Exelon Generation Company, LLC (Exelon)'s application for the subsequent license renewal of its licenses to operate Peach Bottom Atomic Power Station, Units 2 and 3, located in Delta, Pennsylvania. The deadline for filing such a request is November 5, 2018.¹

On October 18, 2018, Beyond Nuclear submitted a request for a two-week extension of the hearing request deadline.² Beyond Nuclear represents that the NRC Staff does not oppose its extension request. Exelon has filed a response opposing the request.³
