SUBJECT: RESPONSE TO NRC INSPECTION 030-37816/2018-001 AND NOTICE OF VIOLATION

Dear Mr. Phillips:

On September 27, 2018, the U.S. Nuclear Regulatory Commission (NRC) cited Intertek Asset Integrity Management, Inc., for a violation that involved the failure to ensure that alarm ratemeters used in industrial radiography require a special means to change the preset alarm function.

The NRC Inspection Report 030-37816/2018-001 with enclosed Notice of Violation (Notice) required you to respond in writing within 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML18275A304). In a letter dated October 16, 2018, you provided your response to the Notice of Violation (ML18304A213).

After reviewing the information provided in your response to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
