This refers to your license amendment request dated August 27, 2018. Please find enclosed Amendment No. 01 authorizing your new location and the release of the location at 761 Main Street, Norwalk, Connecticut. In addition, authorization for research and development activities was removed from the license as you requested.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).


