## ORDER

(Scheduling Telephonic Conference Call)

The Licensing Board previously had scheduled an all-parties status conference in this case for Wednesday, December 5, 2018.<sup>1</sup> As a result of the federal government's closure on that date for the memorial service for former President George H.W. Bush, that conference has been rescheduled for Thursday, December 6, 2018, at 4 pm Eastern Time. The Board anticipates that this conference will last no more than two hours.

During the conference, the Board would like to address the following questions:

#### **NRC Staff**

 What specific measures has the NRC Staff already taken in furtherance of the milestones laid out in its November 21, 2018 letters to Powertech (USA) Inc., and intervenor Oglala Sioux Tribe (ADAMS Accession No. ML18331A431)?

### Oglala Sioux Tribe

- Will the Tribe work with the NRC Staff towards implementation of the March 2018 Approach?<sup>2</sup>
- Does the Tribe have specific objections or alternatives to the survey methodology proposed by the NRC Staff in its November 21, 2018 letter to the Tribe that it would like to discuss with the NRC Staff over the next three weeks? If so, in general what items does the Tribe wish to discuss with the NRC Staff?
- Will the Tribe meet the December 28, 2018 milestone set forth in the NRC Staff's November 21 letter for responding to the NRC Staff's November 21 proposal or providing an alternative proposal? Does the Tribe have any comments about any of the other milestones provided in the NRC Staff's November 21 letter?
- What changes, additions, or revisions does the Tribe believe are necessary to the March 5, 2010 protective order (ADAMS Accession No. ML18159A148) already in effect in this proceeding?

#### Powertech

 Will Powertech continue to provide reimbursement and logistical support for the renewed March 2018 Approach implementation efforts?
