This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if a former Supervisor with the Okonite Company in Richmond, Kentucky was discriminated against for raising nuclear safety concerns. Based on the evidence developed during the OI investigation, the NRC did not substantiate that discrimination occurred.
