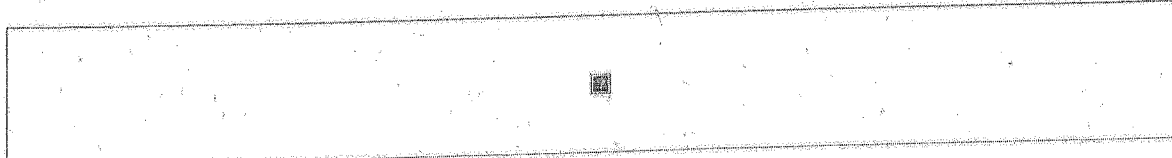

Mr. Scolforo,

10 CFR 30.34 (b)(1) states: "No license issued or granted pursuant to the regulations in this part and parts 31 through 36, and 39 nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing."

The information that needs to be provided is Appendix E of NUREG-1556, Volume 5, Rev 1 <https://www.nrc.gov/reading-m/doc-collections/nuregs/staff/sr1556/v15/>

The licensee and the proposed licensee needs to sign the document. In the request to can change locations, address, personnel.

In addition, include if the proposed licensee currently has an NRC or Agreement State license and if an Agreement State, include that license.

Time to get approval is longer than normal amendments. A 30 day posting is required and the internal review is longer. Also, it might require a pre-licensing visit.
