From December 12-13, 2018, the U.S. Nuclear Regulatory Commission (NRC) conducted a security inspection at the Pennsylvania State Breazeale Reactor facility. The inspection included a review of activities authorized for your facility.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel. Based on the results of this inspection, no findings of non-compliance with NRC requirements were identified. No response to this letter is required.
