This refers to your license amendment request dated November 1, 2018. Please find enclosed Amendment No. 15 authorizing a second location in Michigan. This action is issued concurrently with the termination of License No. 21-32520-01 formerly authorizing licensed activities for Engineering & Environmental Solutions, LLC, a company which you recently acquired. Because your license authorizes locations of use under NRC jurisdiction only in our Region III area, licensing and inspection of your authorized activities will be performed by that office, although we do note that you plan to manage the licensed activities from your New Jersey location.
