This refers to an investigation initiated by the U.S. Nuclear Regulatory Commission's (NRC's) Office of Investigations regarding activities at Grand Gulf Nuclear Station. The Office of Investigations initiated the investigation to determine whether multiple contractor employees willfully received inappropriate assistance from an exam proctor on General Employee Training (GET) exams at the Grand Gulf Nuclear Station.

The NRC has terminated the investigation, and plans no further action.
