Dear Mr. Talavera:

This refers to your license amendment request dated October 9, 2018. Please find enclosed Amendment No. 21 removing Drs. Diaz, Sostre, and Friger and expanding the 10 CFR 35.300 uses for Dr. Vélez-Miró in accordance with his training and experience at Hospital Metropolitano Dr. Susoni and Hospital Hermanos Meléndez, Inc. In addition, please note that: (i) Dr. Shafique has not been added to the license as your license does not include any activities requiring an Authorized Medical Physicist; and (ii) the licensed material listed under 10 CFR 35.400 has been separated by radionuclide.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
