Dear Ms. Casey:

In our phone conversation on Thursday, December 27, 2018, there was some confusion regarding the request to expedite the removal of the address of use listed at 710 North East Street, Wabash, IN 46992 from NRC license # 13-01284-02. It has been verified that the contractor for the demolition has been chosen and we are waiting on the approval of the close-out to move forward.

Per your request, please find the following additional information to support the close-out of the 710 North East St, Wabash, IN location of use:

Item 1:

The last date of use for 35.100 and 35.200 materials was June 18, 2018. The last date of use for 35.300 materials was an I-131 therapy performed on June 4, 2014. Through discussion with the Imaging Radiology Manager and nuclear technologist, review of available dosage and waste records, we have no evidence of the use of materials under 31.11 since 2011.

Item 2:

We have attached the final decay-in-storage record that documents all residual radioactive waste was decayed, surveyed, and disposed of in accordance with 35.92 and 35.2092.

Item 3:

The Ludlum 14C GM survey meter (s/n 292634) with pancake probe used to perform the surveys was calibrated on 8/3/17. The close-out report submitted incorrectly noted the date of the survey meter calibration as 8/3/18. This was the date it was due for annual calibration.


Item 4:

We understand that the 710 North East St, Wabash, IN, facility was the only location licensed for material use under 31.11. We request the removal of the authorization of byproduct material permitted by 10 CFR 31.11 from our NRC license. As stated in Item 1, we have no record of use of materials under 31.11 since 2011. In addition, we request the removal of the following authorized users from our NRC license. These physicians are no longer contracted at Parkview Health.

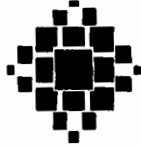
