## TRANSFER OF CONTROL

### NUREG-1556, VOL. 15

1. This license will transfer to Ascension Medical Group-Genesys from Genesys Integrated Diagnostics – Grand Blanc as an asset purchase agreement. The name of the practice will be changing to Ascension Genesys Ambulatory Imaging. The address remains the same at 600 Health Park, Suite B. Grand Blanc, MI 48439. Control of these assets will be given to Ascension Medical Group-Genesys when Transfer of Ownership is granted by the Nuclear Regulatory Commission. Questions about this merger can be answered by Dr. Steve Min, D.O., Radiation Safety Officer at [smin@adirads.com](mailto:smin@adirads.com) or 248-798-7325.
2. Changes in personnel will be a new President, Kenneth Berkovitz, President, Ascension Medical Group-Genesys. Steve Min, D.O., will remain as the Radiation Safety Officer and all authorized users will remain the same on this license.
3. The location, facilities, equipment and procedures that relate to the licensed program will remain the same.
4. The surveillance program will remain intact. Currently the Radiation Protection Program for Genesys Integrated Diagnostics – Grand Blanc will remain the same; daily surveys and weekly wipe testing for contamination. Leak testing is performed on all sealed sources. There will be no changes to this program. The nuclear medicine technologist will remain the same.
5. We are not decommissioning this license. All required documents and records are currently kept in accordance with NRC license conditions. These include, but are not limited to, the annual calibration of survey instruments, semi-annual leak testing of non-exempt sealed radioactive sources, radiation monitoring and personnel exposure monitoring reports. Radiation monitoring is performed on a daily basis for acceptable radiation levels and weekly for removable contamination.

The areas of storage, preparation, handling, and administration of radioactive materials are surveyed daily for acceptable radiation levels and weekly for removable contamination. If contamination of these areas is detected during these daily or weekly surveys, decontamination is undertaken and completed at that time.

6. All parties involved with the transfer are aware and agree to the planned transfer of ownership. Please see the enclosed, signed agreement page.
