This refers to your license amendment request dated November 6, 2018. Please find enclosed Amendment No. 36 authorizing a change in the Survey Plan for Building 315. The plan titled, "Radiological Survey Plan for Structures at Picatinny Arsenal," dated September 2018, along with the amendments as stated in the letter dated December 21, 2018, is accepted. The previous approved documents were removed from License Condition 12.D. and 12.E. of your license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
