Dear Mr. DeLong,

This is in reference to your letter dated November 9, 2018, making notification of License use at a temporary job site concerning Nuclear Regulatory Commission License No. 09-29309-01, Docket No. 03038878. In order to continue our review, we need the following additional information:

1. Condition 13 of your license states, in part, "A copy of this agreement shall be included in the notification required by Condition 18.A. of this license." A copy of the agreement was not included. Please submit a copy of the agreement. Please ensure the other components of the agreement required by Condition 13 is included (i.e. The agreement shall include a commitment by the licensee and customer to ensure safety, and any commitments by the licensee to help the customer clean up the temporary job site if there is an accident).
2. Condition 18. A. of your license states, in part, "This notification shall include: (1) The estimated type, quantity, and physical/chemical forms of licensed material to be used, (2) The specific site location, (3) A description of planned activities including waste management and disposition, (4) The estimated start date and completion date for the job, and (5) The name and title of a point of contact for the job, including information on how to contact the individual."
  - a) You state that exempt quantity sealed sources will be used and potential low level radioactive waste. Please state the estimated type, quantity, and physical/chemical forms of licensed material to be used.
  - b) You stated that the temporary job site would be at Hunters Point Naval Shipyard, but you did not include the specific location. Please state the specific location.
  - c) You state to contact you for additional questions, but it is unclear if you are the point of contact for the job. Please state you are the point of contact for the job or submit a point of contact including how to the contact the individual.

We will continue our review upon receipt of this information. Please reply to my attention at the Region 1 Office (Address below) and refer to Mail Control No. 610650. If you have technical questions regarding this letter, please call me at (610) 337-5366.

Your reply must be an originally signed and dated letter. The letter may be scanned and submitted as a pdf document attached to an email; or it may be transmitted by facsimile to (610) 337-5269; or it may be sent by regular mail. If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application OR amendment request.
