Title: PREDECISIONAL ENFORCEMENT CONFERENCE WITH SOUTHERN CALIFORNIA EDISON COMPANY

Purpose: The purpose of this predecisional enforcement conference is to discuss two apparent violations of U.S. Nuclear Regulatory Commission (NRC) requirements. The apparent violations are related to an incident that involved a loaded spent fuel canister that was misaligned when being lowered into a storage vault and the important to safety lifting and rigging equipment was no longer supporting the canister weight. These apparent violations are discussed in NRC Special Inspection Report 050-00206/2018-005, 050-00361/2018-005, 050-00362/2018-005, 072-00041/2018-001, dated November 28, 2018 (ADAMS Accession ML18332A357).
