This refers to your license amendment request dated October 16, 2018. Please find enclosed Amendment No. 15 authorizing new storage locations and deleting storage locations no longer in use. The storage locations at 420 Middle Turnpike West, Manchester, CT; 403 Allen Street, New Britain, CT; 4 Fourth Street, Ansonia, CT; 58 Nicholdale Road, Shelton, CT; 75 Claudia Drive, West Haven, CT; and 152 Stoddard Wharf Road, Gales Ferry, CT can be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
