Subject: Discussion Topic for Upcoming Public Meeting about Vogle LAR 18-031/Exemption Request and ALT-12

Corey –

The staff has the following discussion topic regarding LAR 18-031, to be discussed at a future public teleconference. Please let me know if SNC can support a discussion at the next public call scheduled for 1/24/19:

- (1) APR1400 DCD Tier 1 states: “When the Design Commitment or ITAAC provides that some thing or some activities must comply with ASME Code Section III, ASME Code Section XI, or the ASME OM Code, this means compliance with the ASME Code, as incorporated by reference in 10 CFR 50.55a with specific conditions, or in accordance with relief granted by the NRC or alternatives authorized by the NRC pursuant to 10 CFR 50.55a.”
- (2) LAR 18-031 proposes changes to Tier 1 (and COL Appendix C) Section 1.2 to be “When the Design Commitment or ITAAC provides that an item or activity must comply with ASME Code Section III, this means compliance with the ASME Code Section III, as incorporated by reference in 10 CFR 50.55a with specific conditions, or in accordance with alternatives authorized by the NRC pursuant to 10 CFR 50.55a.”

SNC takes out the “ASME Code Section XI, or the ASME OM Code” and “relief granted” of original statement (1), as proposed changes (2) of LAR18-031 . The staff would like to have a clarification call with SNC on the differences between the two statements.
