Mr. Scolforo,

This refers to your request for a new license dated November 27, 2018. In order to continue our review of your request, the following additional information is needed:

1. In Item 6. of your application you state that you will be using Troxler Electronic Laboratories models 3400 series, 4640 and 3214. Please state how many of each model of Troxler portable gauges you would like to be able to possess.
2. In your application Item 8., it states that licensed material shall be used by, or under the supervision and in the physical presence of, individuals who have satisfactorily completed the manufacturers training. In NUREG-1556, Vol. 1, Rev. 2 "Consolidated Guidance About Materials Licenses – Program Specific Guidance About Portable Gauge Licenses" states in part that successful completion of one of the following to be evidence of adequate training and experience.

Portable gauge manufacturer's course for users and hands-on training in the use of portable gauges

Or

Equivalent course that meets the criteria in Appendix C of NUREG-1556, Vol. 1, Rev. 2 "Consolidated Guidance About Materials Licenses – Program Specific Guidance About Portable Gauge Licenses"

Please state that licensed material will be used by, or under the supervision and in the physical presence of, individuals who have successfully completed the above training.
