On behalf of the Commission, I am providing the January 2019 monthly status of the U.S. Nuclear Regulatory Commission (NRC) activities and use of unobligated carryover funds appropriated from the Nuclear Waste Fund. The enclosure provides the Nuclear Waste Fund expenditures in January 2019 to address the remand by the U.S. Court of Appeals for the District of Columbia Circuit in the case *In re Aiken County* regarding the licensing process for the U.S. Department of Energy's Yucca Mountain license application. While there are no significant actions to report for the month, NRC staff did provide limited program planning and support and federal court litigation activities that resulted in nominal expenditures.
