As discussed in our letter dated January 25, 2018, the U.S. Nuclear Regulatory Commission (NRC) staff is proposing a teleconference call meeting next week. The purpose of the meeting would be to introduce the NRC staff to the Oglala Sioux Tribe's new Tribal Historic Preservation Officer and discuss the framework for future negotiation meetings regarding the continued development of the pedestrian site survey methodology. The teleconference meeting will be facilitated by Joan Olmstead from the NRC's Federal, State, and Tribal Liaison Branch. Topics for this meeting would include:

- Introductions
- Roles and responsibilities
- Expectations and goal
- Framework for future communications and interactions
  - Frequency of meetings
  - Documenting the meetings
  - Scope of the discussions and negotiations
- Purpose of the February 22, 2019, meeting of the Oglala Sioux Tribe Tribal Advisory Council
- Next steps

The NRC staff also welcomes the involvement of the Tribes that have been invited to participate in the site survey as discussed in the March 16, 2018 Approach. The staff intends invite those Tribes to this meeting once we have scheduled a time that is agreeable to the Oglala Sioux Tribe. The NRC staff, however, continues to rely on and greatly appreciates the Tribe's assistance in coordinating with the other Tribes.
