Dear Mr. Domey,

This is in reference to your letter dated December 17, 2019, requesting for amendment to Nuclear Regulatory Commission License No. 44-14149-02, Docket No. 03032893. In order to continue our review, we need the following additional information:

1. Based on your letter heading, it appears that the agency's name has changed. Currently on the license, we have Vermont Agency of Transportation, Construction & Materials Bureau's Central Laboratory. Please state the name we should use for your organization of that the name we currently have is correct. Please describe any changes in organization that may have occurred with the name change.
2. Please provide additional information about Mr. Domey's training and education. NUREG-1556, Volume 1, Rev. 2, "Consolidated Guidance About Materials Licenses Program-Specific Guidance About Portable Gauge Licenses," states in section 8.7.1 to provide documentation demonstrating that the proposed RSO is qualified by training and experience (e.g., certificate of completion of the RSO's course and/or the authorized user's course) . Please provide a copy of the certificate associated with the Radiation Safety Officer course. Please state if Mr. Domey is currently an authorized user of the portable gauges and how long he has been an authorized user.
3. The location of use at Hardwick, Vermont was added to the license on April 1, 2015. NUREG-1757, Volume 1, Rev. 2, "Consolidated Decommissioning Guidance Decommissioning Process for Materials Licensees," section 8.2 states, for all sealed sources, including those no longer in licensee's possession, provide to NRC results from the most recent leak tests demonstrating there has been no leakage. Please provide the last leak test for all gauges that were stored at that location.

We will continue our review upon receipt of this information. Please reply to my attention at the Region 1 Office (Address below) and refer to Mail Control No. 610994. If you have technical questions regarding this letter, please call me at (610) 337-5366.

Your reply must be an originally signed and dated letter. The letter may be scanned and submitted as a pdf document attached to an email; or it may be transmitted by facsimile to (610) 337-5269; or it may be sent by regular mail. If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application OR amendment request.
