SUMMARY AND ACTION REQUIRED (IF ANY)
 This is a summary of the conversation that occurred between Laura Cender and Jack Niemi on January 4, 2019, regarding the license amendment request dated November 27, 2018. As we discussed today, in order to complete processing of your license amendment request, please provide the following items by no later than January 25, 2019.

1. Please provide a copy of the most recent leak tests for two Seaman Nuclear Corporation Model C-75 gauges that have been disposed of. Additionally, please provide a statement confirming that these are the only two Seaman Nuclear Corporation Model C-75 portable gauging devices that have been possessed under your NRC license.
2. As we will not be able to remove your 2940 Parkview Drive, Petoskey MI facility from your license until the move to 300 E. Mitchell, Petoskey MI is complete, your license will temporarily list six authorized locations of use. As we discussed today, six or more locations of use normally results in a change to your fee category resulting in additional fees. In order to avoid this change in fee category please provide a statement confirming that you will request an amendment to remove the 2940 Parkview Drive, Petoskey MI facility within 60 days of the move occurring.
3. Ohio is an Agreement State, with its own nuclear materials licensing program. You will need to contact the Ohio Department of Health regarding your interest in using and storing licensed radioactive material within the state. A link to their website with contact information is provided in the email accompanying this record.
