

**CERTIFICATE OF MERGER OF
CARDIOLOGY ASSOCIATES OF CENTRAL CONNECTICUT, LLC
AND CONSULTING CARDIOLOGISTS, PC**

To the Secretary of State
State of Connecticut

Pursuant to the provisions of the Connecticut Entity Transaction Act, specifically 34-611 thereof, governing the merger of a domestic limited liability company into a domestic corporation, it is hereby certified:

FIRST. The names of the merging businesses are Cardiology Associates of Central Connecticut, LLC, a limited liability company duly organized under the laws of the State of Connecticut, which is to be the terminating company, and Consulting Cardiologists, PC, a professional corporation duly organized under the laws of the State of Connecticut, which is to be the surviving corporation.

SECOND. An Agreement and Plan of Merger (the "Plan of Merger") for merging Cardiology Associates of Central Connecticut, LLC with and into Consulting Cardiologists, PC was approved by resolution of the Members of the limited liability company and by resolution of the Board of Directors of the professional corporation.

THIRD. In respect of Cardiology Associates of Central Connecticut, LLC,:

(a) there are four (4) Members of the limited liability company and each Member voted in favor of the Plan of Merger.

(b) The Plan of Merger was duly approved by the unanimous vote of Members in the manner required by sections 34-279a to 34-279q, inclusive, of the Connecticut Limited Liability Company Act and the Operating Agreement of Cardiology Associates of Central Connecticut, LLC.

FOURTH. In respect of Consulting Cardiologists, PC:

(a) there is only one class of members of the corporation and there are six (6) members in said class.

(b) The total number of votes cast for and against the Plan of Merger is as follows:

(i) Number of votes cast for Merger 6

(ii) Number of votes cast against Merger 0

(c) The Plan of Merger was duly approved by all members in the manner required by section 33-187 to 33-1290, inclusive, of the Connecticut Business Corporation Act and the certificate of incorporation of Consulting Cardiologists, PC.

FIFTH. The laws of the State of Connecticut, specifically the Connecticut Entity Transaction Act, permit the merger of a limited liability company with and into a professional corporation and the Merger of Cardiology Associates of Central Connecticut, LLC and Consulting Cardiologists, PC is in compliance with the laws of the jurisdiction of the State of Connecticut.

SIXTH. The Plan of Merger provides that Consulting Cardiologists, PC will continue its existence as the surviving corporation under its current name pursuant to the provisions of the laws of the State of Connecticut.

SEVENTH: The Articles of Incorporation of the surviving corporation shall remain the same as currently stated.

EIGHTH: The Merger shall become effective on January 1, 2019.







Dear Dr. Walden:

By the letter dated August 8, 2018, Consulting Cardiologists, P.C. (CC) and Cardiology Associates of Central Connecticut, LLC (CACC) requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a proposed direct transfer of control of CACC's license to CC. From your letter, we understand that this transfer will result from a merger of CACC into CC, and that all operations will continue under the CC name and tax identification number. It is also our understanding that this transaction will not result in any change to the location of use, materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility.

Based on the above understandings, as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the request, the NRC consents to the proposed transfer. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the agreement confirming completion of the transaction. With this information, we can issue an administrative amendment to your NRC license to reflect the transaction, if necessary. Please notify the NRC in writing, if this planned merger has not been consummated within 30 days of the proposed date of merger, which is expected to occur on January 1, 2019, or the NRC may deem this consent to be null and void. Based on the above understandings, the NRC consents to the proposed direct transfer of control of NRC Materials License No. 06-28274-01. Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.

SUMMARY AND CONCLUSIONS

Consulting Cardiologists, P.C. (CC) is authorized by NRC License 06-28274-01 for the possession and medical use of byproduct material for diagnostic studies permitted by 10 CFR 35.100 and 35.200 at 305 Western Boulevard, Building G, Glastonbury, Connecticut and 100 Sinsbury Road, Suite 202, Avon, Connecticut. Cardiology Associates of Central Connecticut, LLC (CACC) is authorized by NRC License 06-30842-01 for the possession and medical use of byproduct material for diagnostic studies permitted by 10 CFR 35.100, 35.200, and Gadolinium-153 under 35.500 at 1062 Barnes Road, Suite 300, Wallingford, Connecticut. The U.S. Nuclear Regulatory Commission (NRC) staff reviewed a request for consent to a direct license transfer submitted by CC and CACC that will result from a merger between the two licensees. CC and CACC will become one entity and will maintain the CC name and federal tax identification number on both licenses. This will be a merger of equals in which all assets will be pooled and shareholders from both practices will surrender their shares for new ones issued by the newly configured company. All physician shareholders will be equal partners in the new CC. After the merger has occurred, CC will submit an amendment request so that all facilities will be consolidated under the 06-28274-01 license, and the 06-30842-01 license will be terminated. The direct transfer of control is described in Agency Documents Access and Management System (ADAMS) package accession number ML18236A339. The ADAMS package consists of the following agency documents: letter dated August 8, 2018 (ML18236A340), email requesting additional information dated September 12, 2018 (ML18262A321), and letter received October 18, 2018 (ML18297A198).

The licensee's request for consent to a direct transfer of ownership was posted for public comment on the NRC website for 30 days in accordance with 10 CFR Part 2 and following the guidance provided in the NRC's Regulatory Issue Summary 2014-08. No comments were received from members of the public.

The request for consent was reviewed by NRC staff for a direct transfer of control of a 10 CFR Part 30 license using the guidance in NUREG-1556, Volume 15, Rev. 1, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses," dated June 2016. The NRC staff finds that the information submitted by CC and CACC sufficiently describes and documents the transaction and commitments made by both parties.

As required by 10 CFR 30.34 and section 184 of the Atomic Energy Act of 1954, as amended (the Act), NRC staff has reviewed the application and finds that the proposed transfer of control is in accordance with the Act. The staff finds that, after the transfer of control, CC will remain qualified to use byproduct material for the purpose requested and will continue to have the equipment, facilities, and procedures needed to protect public health and safety and to promote the common defense and security.

SAFETY AND SECURITY REVIEW

According to data obtained from the NRC's Web Based Licensing system, Consulting Cardiologists, P.C. (CC) has been an NRC licensee since March 15, 1989. The NRC conducted an inspection at the Glastonbury and Avon, Connecticut locations on March 21, 2018, with a telephonic exit meeting on April 25, 2018, and one Severity Level IV violation was identified. The licensee did not calibrate instrumentation used to measure the activity of unsealed byproduct material at its new Glastonbury location in accordance with nationally recognized standards or the manufacturer's instructions, in accordance with 10 CFR 35.60(b). According to data obtained from the NRC's Web Based Licensing system, Cardiology Associates of Central Connecticut, LLC (CACC) has been an NRC licensee since October 20, 2003. The NRC conducted an inspection at the Wallingford, Connecticut location on March 18, 2015, and no violations were identified. The commitments made by CC and CACC state that there will be:

- A. no change to the radiation safety officer listed on the NRC licenses;
- B. no change in personnel involved in licensed activities;
- C. no change in the locations, facilities, and equipment authorized in the NRC licenses;
- D. no change in the radiation safety program authorized in the NRC licenses;
and
- E. no change in the organization's name listed in the NRC license 06-28274-01; the organization's name listed in the NRC license 06-30842-01 will be changed to Consulting Cardiologists, P.C.

Further, the licensees will maintain required surveillance records and decommissioning records as required by NRC regulations. After the transaction, the licensees will submit an amendment request to consolidate all facilities onto the NRC license 06-28274-01, and request that NRC license 06-30842-01 be terminated.

For security purposes, CC and CACC are considered known entities following the guidance provided by the NRC's Office of Federal and State Materials and Environmental Management Programs (FSME) "Checklist to provide a basis for confidence that radioactive materials will be used as specified on the license," September 3, 2008 revision. The purpose of this checklist is for the NRC to obtain reasonable assurance from new license applicants or NRC licensees transferring control of licensed activities that the licensed material will be used for its intended purpose and not for malevolent use.

Consulting Cardiologists, P.C. (CC) is not required to have decommissioning financial assurance based on the types and amount of material authorized in License No. 06-28274-01, as outlined by 10 CFR 30.35. Cardiology Associates of Central Connecticut, LLC (CACC) is not required to have decommissioning financial assurance based on the types and amount of material authorized in License No. 06-30842-01, as outlined by 10 CFR 30.35.

REGULATORY FRAMEWORK

CC's License No. 06-28274-01 and CACC's License No. 06-30842-01 were issued under 10 CFR Part 30, "Rules of General Applicability to Domestic Licensing of Byproduct Material." The Commission is required by 10 CFR 30.34 to determine if the transfer of control is in accordance with the provisions of the Act and give its consent in writing.

10 CFR 30.34(b) states: "No license issued or granted pursuant to the regulations in this part and parts 31 through 36, and 39 nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing."

As previously indicated, the staff evaluation is based on guidance in NUREG-1556, Volume 15, Revision 1. CC's and CACC's request for consent describes a direct transfer of control and, as such, the transfer requires NRC consent.

DESCRIPTION OF TRANSACTION

The direct transfer of control is described in Agency Documents Access and Management System (ADAMS) package accession number ML18236A339. The ADAMS package consists of the following agency documents: letter dated August 8, 2018 (ML18236A340), email requesting additional information dated September 12, 2018 (ML18262A321), and letter received October 18, 2018 (ML18297A198). After completion of the merger, CC will continue as the licensee and remain in control of all licensed activities under Materials License Nos. 06-28274-01 and 06-30842-01. The NRC staff finds that the request for consent adequately provides a complete and clear description of the transaction and is consistent with the guidance provided in Appendix E of NUREG-1556, Volume 15, Revision 1.

TRANSFeree'S COMMITMENT TO ABIDE BY THE TRANSFEROR'S COMMITMENTS

The NRC staff finds that the information submitted by Consulting Cardiologists, P.C. and Cardiology Associates of Central Connecticut, LLC sufficiently describes and documents the commitments made by both parties and is consistent with the guidance in NUREG-1556, Volume 15, Revision 1.

ENVIRONMENTAL REVIEW

An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c)(21).

CONCLUSION

The staff has reviewed the request for consent submitted by the licensee with regard to a direct transfer of control of byproduct materials license Nos. 06-28274-01 and 06-30842-01; and consents to the transfer pursuant to 10 CFR 30.34(b).

Consistent with the guidance in NUREG-1556, Volume 15, Revision 1, the submitted information sufficiently describes the transaction; documents the understanding of the license and commitments of the transferee; demonstrates that personnel have the experience and training to properly implement and maintain the license and that they will maintain the existing records; and provides that, in the future, the transferee will abide by all existing commitments on the license.

Therefore, the staff concludes that the proposed transfer of control would not alter the previous findings, made under 10 CFR Part 30, that licensed operations will not be inimical to the common defense and security, or to the health and safety of the public.
