I am requesting all documents in the NRC's possession related to a June 1971 compliance inspection by the United States Atomic Energy Commission which may have resulted in a Notice of Violation and a request for remedial action to be taken to remediate thorium-bearing slag that was discovered at the Molycorp, Inc. site in Washington, Pennsylvania. This request includes, but is not limited to, any sampling, reports, regulations, guidance documents, or remediation plans.
