The licensee requested in letter dated January 4, 2019 (ML19009A301), to retract the amendment request submitted to NRC dated November 9, 2018, (ML18312A042) regarding the possession and human use of the Galli Eo Germanium-68/Gallium-68 Generator. The retraction was based on a previous telephone discussion with the Radiation Safety Officer (RSO), Maxwell Amurao, Ph.D., MBA, on December 4, 2018, in which it was discussed and determined that the use of the Galli Eo Germanium-68/Gallium-68 Generator would be authorized as human research. Since human use (for the requested possession limit and isotopes) is currently authorized on the license, the initial submitted amendment request dated January 4, 2019 would be withdrawn. The RSO was contacted on January 31, 2019 (attached telephone conversation), to discuss the retraction and informed that the licensing action (Mail Control No. 610421) would be voided per our telephone conversation. The RSO agreed and understood the void and had no further questions. This voided action was discussed with the Chief, Material Licensing Branch on January 29, 2019. Therefore, in accordance with the licensee's letter dated January 4, 2019 and the January 31, 2019 telephone conversation with the RSO and a discussion on January 29, 2019, with the Chief, Material Licensing Branch the licensing action is voided.
