This letter is in response to your email dated January 25, 2019 regarding our request to add Ms. Kelli Zauner to the subject license. The entirety of Ms. Zauner's handling experience (as detailed on her preceptor form) took place at the PETNET facility in Royal Oak, where she handled F-18 almost exclusively (as well as low-activity sealed sources). Since most pharmacists at PETNET are not trained to perform or participate in cyclotron maintenance or repair activities, they are not expected to handle any activation products. (Cyclotron maintenance and repairs are performed by the site's cyclotron engineer, who also handles the site's longer-lived wastes.) In the rare care a pharmacist is expected to perform these tasks, they receive training in advance.

We have reviewed the January 4, 2019 letter (ML19008A257) requesting to add Kelli Zauner, R.Ph., as an Authorized User (AU) on your the license referenced in the subject line of this message. Please note that additional information is needed to complete our review. Accordingly, please provide a response to the item noted below, to complete the review of your request:

- In the application, it is unclear the extent of experience Ms. Zauner has in the handling of radioactive materials relevant to accelerator activities. Please provide additional training details for Ms. Zauner, including to clarify:
 - The types, forms (including activated targets and incidentally activated products associated with accelerator activities), and quantities of material Ms. Zauner will be expected to handle, under the license; and
 - Ms. Zauner's experience with the types, forms, and quantities of material Ms. Zauner will be
 expected to handle, under the license.

Note that details of Ms. Zauner's experience should include the locations of that experience, dates on which that experience was completed, typical & maximum radioactive quantities handled, forms (such as accelerator targets or other accelerator-produced items) handled or used, and radionuclides handled or used. Experience should be specific to accelerator production and need not include experience towards her qualifications to be listed as an Authorized Nuclear Pharmacist (ANP) on NRC License No. 41-32720-05MD.

In order to add Ms. Zauner as an AU, please submit requested information within 14 days (on or before February 8, 2019). If you are unable to respond by then, please let us know as soon as possible when you will be able to provide a response. Additional guidance may be found in NUREG 1556, Vol. 21, rev. 1, "Program Program-Specific Guidance about Commercial Radiopharmacy Licenses," which may be found at:
