Subject: Request to Modify Condition and Limitation 2 to WCAP-12610-P-A & CENPD-404-P-A,  
Addendum 1-A, "**Optimized ZIRLO™**"

During the Westinghouse Fuel Performance Update Meeting (FPUM) held July 18 – 19, 2018 at the Westinghouse offices in Rockville, Westinghouse expressed the desire to pursue a limited-scope review of WCAP-12610-P-A and CENPD-404-P-A, Addendum 1A. The request would seek to modify Condition and Limitation 2 of WCAP-12610-P-A and CENPD-404-P-A, Addendum 1A consistent with a more recent approval in WCAP-16500-P-A.
