FOR WESTERN NUCLEAR, INC. SOURCE MATERIALS LICENSE NO. SUA-56

Dear Ms. Thomas:

This letter is to inform Western Nuclear, Inc. (WNI) that the U.S. Nuclear Regulatory Commission (NRC) is cancelling and returning the financial assurance WNI provided to the NRC with respect to WNI's Source Materials License No. SUA-56 for its Split Rock mill site.

WNI is no longer required to maintain financial assurance with respect to this NRC license as Wyoming (WY), now an Agreement State, has regulatory authority over the mill site. By letter dated January 11, 2019, WY has indicated that it has obtained satisfactory financial assurance for the mill site (Agencywide Document Access and Management System (ADAMS) Accession No. ML19038A170). Therefore, NRC is now cancelling and returning the financial assurance instruments that were provided to NRC for this mill site.

The financial assurance instruments that WNI provided in connection with this license was a payment surety bond issued by Westchester Fire Insurance Company and a standby trust agreement issued by Wells Fargo Bank, N.A. In addition, a previously superseded parent company guarantee (PCG) instrument is also being returned. The surety bond, including amendments, PCG, and standby trust agreement have been cancelled and are being returned to WNI at this time.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
