In accordance with your request (Reference a.) and pursuant to Title 17, California Code of Regulations (17 CCR) 30225(a), you are hereby authorized to use radioactive materials at temporary job sites in areas not under exclusive Federal jurisdiction throughout the State of California. Such use shall be conducted in accordance with 17 CCR, your Radioactive Materials License (Reference b), and the special conditions stated in this letter. These documents must be available at California job sites when work is being performed under this authorization. An order form to obtain a copy of the regulations is enclosed.

**Notification:**

You are further required to provide written notification (via mail or fax) at least three working days prior to each use of radioactive material in California so that we may inspect such use should we choose to do so. We would appreciate earlier notification, 10 working days, if that is possible. If there is a change in the date of work, you must notify our office immediately.


appropriate inspection office of work in their inspection area. Please see the enclosed map to determine the proper inspection office and fax number for that notification.

**Special Conditions:**

1. Your reciprocal authorization expires on **December 31, 2019**. If you intend to use radioactive materials within California after this date, you must reapply.
2. Radioactive material may not be used, stored, or possessed within California for more than **180** days during this authorization period.
3. A copy of this letter and the appropriate sections of 17 CCR must be carried at all times when radioactive material is used in California under this authorization.
4. All sealed sources, tools or devices coming into California must have the current leak test available for review.
