1. Please review the applicable guidance in NUREG 1556, Vol. 1, Rev. 2 and the attached license application checklist. You will need to resubmit your application addressing all the areas discussed in the checklist.
2. In your application, you did not indicate if you intend to use gauges at temporary job sites. In addition, your NRC form 313 did not reference the correct license number and was not signed by senior management. Please indicate in your response if you will be using the gauges at temporary job sites, reference the appropriate NRC license number, and have NRC form 313 signed by senior management.
3. In your application, you you did not provide facility drawings for the areas where gauges will be stored. In your response please provide a current facility diagram.
