Discussion: I discussed with Mr. DeLong, that I did not see where he was meeting the requirement in License Condition 13 which says, "The agreement shall include a commitment by the licensee and customer to ensure safety, and any commitments by the licensee to help the customer clean up the temporary job site if there is an accident." Mr. DeLong stated that their job was to do clean up on the site. I stated that it needed to state in the agreement, that they would do that in an emergency. He said that the levels of activity are so low, it is not detectable. I told him that he needed to follow License Condition 13 anyways as it is a license requirement. He said that he would get the memorandum of understanding revised to include this statement.

Action Required: Mr. DeLong to amend the memorandum of understanding.
