The Office of Nuclear Security and Incident Response has completed its review of Revision 20 to the Physical Protection Plan submitted by Nuclear Fuel Services, Inc. (NFS) on September 21, 2018.

The methods and procedures outlined in NFS's Physical Protection Plan, Revision 20, satisfy the performance objectives, systems capabilities, and reporting requirements specified in Title 10 of the *Code of Federal Regulations* sections 73.45, 73.46, and applicable NRC security orders. Therefore, the U.S. Nuclear Regulatory Commission staff finds that the current NFS Physical Protection Plan, Revision 20, is acceptable and provides high assurance that the requirements for the physical protection of Strategic Special Nuclear Materials will be met.
