The U.S. Nuclear Regulatory Commission (NRC) received a license amendment request from United Nuclear Corporation (UNC) to amend its Source Materials License Number SUA-1475 to bring Northeast Church Rock mine waste onto the Church Rock mill site located in McKinley County, New Mexico. We are reaching out to the Octavia Fellin Public Library to request its assistance in establishing an information repository and maintaining reference documents at the library. The documents are associated with the NRC's environmental review of the UNC site source material license amendment request.
