Please accept this letter as our notification to the Regional Administrator, U.S. Nuclear Regulatory Commission, at the Region 1 Office in accordance with Section 18 A. of Ameriphysics, LLC NRC Radioactive Materials License Number 41-35264-01.

Ameriphysics, LLC (Ameriphysics) has been contracted to perform packaging and shipment for radioactive sources for processing and disposal. The work activities include:

Inventorying, packaging and shipment of 158 sources of various forms and isotopes with 47.4 mCi of total decayed activity.

Isotopes(# sources) include; Ba-133 (14), Bi-210 (1), C-14 (11), Cd109 (2), Ce/Pr-144 (1), Ci-36 (2), Co-57 (2), Co-60 (7), Cs-137 (30), H-3 (13), I-125/I-129 (1), I-125/Am-241 (1), I-129 (3), Mn-54 (4), Na22 (5), P-32 (1), Pa-234(1), Pb/Bi-210 (1), Po-210 (1), Ra-226 (2), I-125 (1), Tc-99 (1), (2), and Zn-65 (1). The sources are all solid and liquid sealed sources (mostly check sources). The total volume is ~ 2 ft³.
