Please find enclosed Amendment No. 8, terminating License No. 08-31338-01 as requested by your NRC Form 314 dated October 17, 2018 (ML18295A040). License No. 08-31338-01 expired on September 30, 2018, but was not terminated until the date of this letter due to a pending enforcement action that was closed with NRC Notice of Violation (NOV) letter dated February 7, 2019 (ML19038A444). A new license was issued to FMC & Associates, LLC, on October 18, 2018 (ML18295A024). All materials that were possessed on the terminated license, License No. 08-31338-01, Docket No. 03037848, were transferred to the new license, License No. 08-31338-02, Docket No. 03039130.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
