Aloha Jean,

Thanks for the map. The area where this is going on hasn't been surveyed so I would recommend a standard 106 consultation where you consult with the NM SHPO and tribes with interest in McKinley Co, NM.... A survey may be needed though unlikely due to the disturbance and alterations to the landform. Tribes that may not be in McKinley Co. (I think most of these are) but may be interested would include the Pueblos of Laguna, Acoma, Zuni, and Isleta, the Navajo Nation and the Hopi of Arizona.

Once we receive your letter, Bob Estes will be the reviewer and will contact you on the results of the review.

Thank you for the contact list and map.

On Friday I read over sections of the 2008 EA and noticed that the section numbers were different and wondered about that. Thank you for confirming that thought in your email.

Regarding tribal consultation, the assumptions you mentioned are correct, the system is built on the tailing pile and this is below the survey area. I also agree it is not the type of activity to impact historic properties if they were present. Later this week I'll send you a copy of the map (after I receive my replacement computer :-)) that will be included in our letter to the NM SHPO so you have that piece of information as well. I can wait a bit on the tribal consultation as we make a determination on the need to perform it.

Hi Jean,

Attached are our various contact lists for tribes. You should be able to find what you need between the three. Thank you for the NMCRIS number to the report... I'll be able to access the report with that info.

I did notice the area surveyed under NMCRIS 100406 (I can look this up on our digital database) does not match up with the Township, Range, and Section you provided me over the phone. The surveyed space is just above the T, R, & Sec you gave me. Once I look at the report I may have a better idea of what's going on. The areas surveyed for NMCRIS 100406 did produce 12 sites but again, we may be talking about two different areas.

I attached a map from our records database showing the space surveyed under NMCRIS 100406 in aqua blue... the T, R, & Section you gave me is just below the surveyed areas... Section 26 on the attached map. Depending on the map you send me and the location of the tanks, especially if they are on top of the tailing pile, I doubt there is any potential for this undertaking to effect historic properties and it may not be necessary to consult with tribes.
