SUPPLEMENTAL INFORMATION TO AMENDMENT TO THE OPERATING LICENSE TECHNICAL SPECIFICATIONS CHANGE NO. 57
SURRY POWER STATION - UNITS 1 AND 2

Pursuant to 10CFR 50.90, the Virginia Electric and Power Company in our letters of August 9, 1977 (Serial No. 344), August 26, 1977 (Serial No. 372), and September 9, 1977 (Serial No. 403) requested an amendment to Operating Licenses DPR-32 and DPR-37. The amendment requested was Change No. 57 to the Technical Specifications. The submittals of August 9, 1977 and August 26, 1977 concerned raising the steam generator tube plugging limit (from an accident analysis standpoint) from the current limits of 19% for Unit 1 and 20% for Unit 2 to 25% for both units. The submittal of September 9, 1977 concerned the reload for Surry 2, Cycle 4.

In a letter from Mr. R. W. Reid dated September 30, 1977, the NRC staff formally requested additional information concerning the Surry 2, Cycle 4 reload submittal of September 9, 1977. Transmitted herewith as Attachment 1 are our responses to that request. This information is the same as that informally transmitted to the staff on September 28 and October 3, 1977.

As this submittal contains information proprietary to Westinghouse Electric Corporation (namely, the response to Request No. 5 given in Attachment 1 to this letter), it is supported by previously submitted affidavits signed by Westinghouse, the owner of the information (see Attachment 2 to this letter). The affidavits set forth the basis on which the information may be withheld from public disclosure by the Commission and address with specificity the considerations listed in paragraph (b)(4) of Section 2.790 of the Commission's regulation.

Accordingly, it is respectfully requested that the information which is proprietary to Westinghouse be withheld from public disclosure in accordance with 10CFR Section 2.790 of the Commission's regulations.
