Dear Dr. Wiest:

This letter refers to your February 21, 2019, correspondence, in response to the subject inspection report which you received on October 22, 2018. The inspection report documented one violation of NRC requirements related to the failure by West Virginia Wesleyan College to perform annual reviews of the radiation safety program content and implementation, as required by Title 10 of the Code of Federal Regulations Part 20.1101(c). The violation was classified at Severity Level IV.

In your letter dated February 21, 2019, you disputed the violation and provided the basis for your dispute. The NRC is in the process of reviewing the information you provided and will notify you of the results of our review when it is complete. You are not required to respond to this letter.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and your response, if you choose to provide one, will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS), accessible from the NRC Website at http://www.nrc.gov/reading-rm/adams.html. To the extent possible, your response, if you choose to provide one, should not include any personal privacy, proprietary, or safeguards information so that it can be made available to the Public without redaction.
