The biennial update period between April 13, 2019 and April 9, 2020 will be satisfied through a future submittal.

Consistent with NAC administrative practice, the NAC-MPC FSAR, Revision 12, changed pages are uniquely identified by the revision number located in the header of each revised page. Revision bars mark the FSAR text changes. Due to text flow, some Revision 12 pages may not contain any revision bars. A description of all of the changes incorporated in Revision 12 of the NAC-MPC FSAR is provided in Enclosure 1. Contained in Enclosure 2 is a certificate of the accuracy for the Revision 12 changes, signed by a duly authorized officer of NAC.


