This refers to your license amendment request dated February 25, 2019, and your subsequent letter dated March 15, 2019. Please find enclosed Amendment No. 21 removing 4 authorized users. As discussed with Evan Western of your staff, the information submitted in the request dated February 25, 2019, was not added to the licensing basis because the information did not amend any of the commitments currently in the license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
