

Mallinckrodt Medical B.V. becomes Curium Netherlands B.V.**

Dear Valued Nuclear Medicine Partners and Customers,

As you were informed, the acquisition by IBA Molecular of Mallinckrodt Nuclear Imaging in January 2017 joined together two leading nuclear imaging businesses with complementary strengths, manufacturing capabilities, commercial footprints and operational networks. In April 2017 the combined Nuclear Medicine business adopted CURIUM as the trade name for the global organization.

Within this framework, we are delighted to announce that our local company name will change as of May 15th, 2019, from Mallinckrodt Medical B.V. to Curium Netherlands B.V. for the company to be clearly identified as a member of the global CURIUM organization.

Curium Netherlands B.V. remains the same legal entity with the same company banking account information, with no change except for the new entity name. Accordingly, this change of name does not affect the validity of agreements concluded with our company, which remain unchanged, in full force and effect, and with same terms and obligations.
