This refers to your license amendment request dated February 14, 2019. Please find enclosed Amendment No. 1 authorizing you to remove Global Threat Reduction Initiative (GTRI) Domestic Threat Reduction Program & Federally Funded Voluntary Security Enhancements for High-Risk Radiological Material additional security enhancements on device models authorized by your license and are being decommissioned.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
