This is in reference to your letter dated January 22, 2019, notifying the NRC that the proposed merger of Cardiology Associates of Central Connecticut, LLC (CACC) into Consulting Cardiologists, P.C. (CC) was finalized and became effective January 1, 2019. In accordance with 10 CFR 30.34(b), your letter is accepted as the required notification. No further correspondence on this matter is required. This also refers to your license amendment request dated March 19, 2019. Please find enclosed Amendment No. 20, which adds the location of use, authorized users, and Gadolinium-153 source from the CACC license under NRC license number 06-30842-01 to the CC license. This amendment is being issued concurrently with the termination of the CACC license under mail control number 611552. In addition, this amendment adds Robert J. Golub, M.D. as Associate Radiation Safety Officer (ARSO).

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy. 
