This refers to your license amendment request dated January 16, 2019. Please find enclosed Amendment No. 8 removing David W. Cheng, M.D., Ph.D. as an authorized user, removing John P. Seibyl, M.D. as Radiation Safety Officer, adding Indukala Doddamane, M.D. as an Authorized User and replacing Dr. Seibyl as Radiation Safety Officer. In addition, in accordance with your letter dated April 9, 2019, we have removed authorization for Hydrogen-3 from your license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. 

