Subject: Amendment Clarification

Discussion: I discussed with Mr. Nostrand why they needed the license. He said that they wanted to remove the Global Threat Reduction Initiative (GTRI) Domestic Threat Reduction Program & Federally Funded Voluntary Security Enhancements for High-Risk Radiological Material additional security enhancements installed on irradiators, for irradiators that are being decommissioned. They would not be installing new sources to these irradiators nor would they be installing the security enhancements. I told him to submit a letter committing to only removing the additional security enhancements for the irradiators that are being decommissioned.
