SUBJECT: NRC INSPECTION REPORT 030-36174/2019-001 AND NOTICE OF VIOLATION

Dear Mr. Wadsworth:

This letter refers to an inspection conducted on January 22, 2019, at the location listed on your license in Livermore, California, with additional in-office inspection activities conducted through March 1, 2019. The purpose of this inspection was to examine activities conducted under your license as they relate to public health and safety, to confirm compliance with the U.S. Nuclear Regulatory Commission's (NRC) rules, regulations, and with the conditions of your license.

Unfortunately, New World Environmental, Inc., is no longer located at the address listed on your license, and my inspection staff was unable to contact you at any of the email addresses or phone numbers you provided to the NRC, therefore, an exit meeting was not conducted.

Regardless, based on the results of this inspection, the NRC has determined that a Severity Level IV violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy, which can be found at the NRC's Website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation is cited in the enclosed Notice of Violation (Notice) because it was identified by the NRC during the inspection. The violation involves an incorrect address listed on New World Environmental's NRC license.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. The guidance in NRC Information Notice 96-28, "Suggested Guidance Relating to Development and Implementation of Corrective Action," may be helpful in preparing your response. You can find the Information Notice on the NRC website at: <http://pbadupws.nrc.gov/docs/ML0612/ML061240509.pdf>.

Information regarding (1) the reason for the violation, (2) the corrective actions already taken and (3) those planned to correct the violation and prevent recurrence, and (4) the date when full compliance will be achieved needs to be addressed. The NRC review of your response to the Notice will also determine whether further enforcement action is necessary to ensure compliance with regulatory requirements. Additionally, as part of your response, the NRC requests that you provide your current contact information and schedule a date and time for an onsite inspection.

To the extent possible, your response should not include any personal privacy or proprietary information so that it can be made available to the Public without redaction. If personal or proprietary information is necessary to provide an acceptable response, please provide a bracketed copy of your response that identifies the information that should be protected and a redacted copy of your response that deletes such information. If you request withholding of such information, you must specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim of withholding (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by Title 10 of the *Code of Federal Regulations* (CFR) 2.390(b) to support a request for withholding confidential commercial or financial information).

NOTICE OF VIOLATION

New World Environmental, Inc.
Livermore, California

During an NRC inspection conducted on January 22, 2019, a violation of NRC requirements was identified. In accordance with the NRC Enforcement Policy, the violation is listed below:

- A. License Condition 2 of NRC Materials License 04-27745-01 specifies the main office location of New World Environmental, Inc., as 448 Commerce Way Livermore, California.

Contrary to the above, from January 22, 2019, (the date of the NRC onsite inspection) until present day, the licensee was not located at 448 Commerce Way Livermore, California. Specifically, an updated main office location has not been provided to the NRC.

This is a Severity Level IV violation (Enforcement Policy Section 6.3.d).

Pursuant to the provisions of 10 CFR 2.201, New World Environmental, Inc., is hereby required to submit a written statement or explanation to the U.S. Nuclear Regulatory Commission; ATTN: Document Control Desk; Washington, DC 20555-0001, with a copy to the Regional Administrator; U.S. Nuclear Regulatory Commission Region IV; 1600 E. Lamar Blvd. Arlington, Texas 76011, within 30 days of the date of the letter transmitting this Notice of Violation (Notice).

This reply should be clearly marked as a "Reply to a Notice of Violation" and should include for the violation: (1) the reason for the violation, or, if contested, the basis for disputing the violation or severity level; (2) the corrective steps that have been taken and the results achieved; (3) the corrective steps that will be taken; and (4) the date when full compliance will be achieved. Your response may reference or include previous docketed correspondence, if the correspondence adequately addresses the required response. If an adequate reply is not received within the time specified in this Notice, an order or a Demand for Information may be issued requiring information as to why the license should not be modified, suspended, or revoked, or why such other action as may be proper should not be taken. Where good cause is shown, consideration will be given to extending the response time.

If you contest this enforcement action, you should also provide a copy of your response, with the basis for your denial, to the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

Your response will be made available electronically for public inspection in the NRC Public Document Room or in the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Website at <http://www.nrc.gov/reading-rm/adams.html>.

To the extent possible, your response should not include any personal privacy, proprietary, or safeguards information so that it can be made available to the public without redaction. If personal privacy or proprietary information is necessary to provide an acceptable response, then please provide a bracketed copy of your response that identifies the information that

If you request withholding of such material, you must specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim of withholding (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by 10 CFR 2.390(b) to support a request for withholding confidential commercial or financial information). If safeguards information is necessary to provide an acceptable response, please provide the level of protection described in 10 CFR 73.21. If Classified Information is necessary to provide an acceptable response, please provide the level of protection described in 10 CFR Part 95.
