As per instructions from Roberto J. Torres, I am writing to affect a transfer of ownership of licensed activities authorized by materials license number 11-29089-01. The expiration date of this license is November 30, 2025.

The transferor of this license is Tiegs AG Consulting, 10971 Chicken Dinner Rd, Caldwell, ID, 83607.

The transferee is Agua La Tierra, LLC, its agent being Dale Jeffers. The mailing address for this company is 5691 Diamond Ridge Way, Nampa, ID 83686.

Upon transfer of ownership Leland Tiegs will cease to be the Radiation Safety Officer, and Arron Mai will take over this position for Dale Jeffers. Arron most recently completed nuclear moisture gauge training on April 18, 2017. He has been operating the sealed source gauges for over 6 years under the direction of the Transferor.

Upon transfer, the location of the two sealed sources and the location of licensee records will change to 14707 Surrey Lane, Nampa Idaho, 83686. Please see attachment A, which describes the new storage location at this address. The radiation safety program, use, possession, and all other procedures that relate to this license will remain the same.

The Transferor is currently in full compliance with the its license; including but not limited to training, radiation safety program, leak tests(most recent copies attached), quality control and record keeping. The current RSO, Leland Tiegs, will be involved in insuring that the new RSO, Arron Mai, maintains the current level of compliance.

Decommissioning Funding Plans are not applicable to this license, and no financial assurance instruments should be required for this transfer. Our leak tests on the two CPN 503DR Hydro probes have always passed. We will just change the storage locations as we have done in the past with no decommissioning required.


Both the transferee and the transferor agree to the transfer of this license. The transferor assures that there are no open inspection items that could result in enforcement actions.
